Township Manager

1. The Township Manager advised the Board that she has provided them per Council's request a letter from the Township's Building Inspector with respect to the current status under the Building Code of the property at 3575 Airport Road.

The Township Manager advised the Board that they have received a copy of correspondence from Township Code Enforcement Officer Robin Yoder setting forth his resignation of his position as Code Enforcement Officer effective immediately. The Township Manager noted that the Board needs to determine what future action they wish to take in terms of hiring a replacement or not and that she would set up a meeting with the head of that department to discuss this matter.

1. With respect to the FedEx project, the Township Engineer noted that the Hanover Township portion of Willowbrook Road work has not been started yet. He noted that the developer is still working on the permit necessary from DEP for the culvert crossing. Once everything is in place, he believes that they will want to do the sanitary sewer work for the project.

New Business:

Vice Chairman Heimbecker advised the Board that he attended a seminar today relative to one well of the Marcellus Shale producing 10 million cubic feet of gas per day. He indicated that the areas in question are West Virginia, Pennsylvania and New York, which would be the third largest energy producer of the world. Vice Chairman Heimbecker questioned why gas is not available throughout the Township. He noted that 51% of the homes had gas. However, there is no gas on Sherwood Street. There was a discussion with respect to the fact that UGI feels it is not worthwhile unless everybody agrees to have gas services in that area. Vice Chairman Heimbecker felt we should revisit the issue with UGI. Jeff Mouer, the Township Maintenance Supervisor noted that it was his understanding that everyone would have to pay for the work to install the pipeline and that 100% participation would be required. The Township Engineer noted that UGI has changed their policies and that they would charge to run the service into the home after the installation of a gas line in the area would be accomplished. There was discussion with respect to finding out the construction cost to running such a line. Mr. Mouer noted that he has the contact information with respect to the man he spoke with who had indicated he would be willing to address the issue with the Township. Chairman Paulus commented that the Township should offer him the opportunity to come in and talk to the Board to discuss gas service. The Township Maintenance Supervisor would contact the UGI representative regarding such a meeting.
