New Business:

1. Bill No. 2024-04, An Ordinance Amending Chapter 1, Part 2, Section 1-203(C) of the Statutory Code of Hanover Township to Allow Joint Municipal Electronic Bids to be Opened Before a Public Meeting of or by a Municipal Engineer of a Participating Municipality (Introduce)

The Township Attorney reviewed this Ordinance. Presently our administrative code does not allow this. Hanover Township has joined other municipalities to save time and expense with the joint electronic bid which will be opened on May 31 at a neighboring municipality. This could save a tremendous amount of money. We need this update for the future. This is an introduction.

2. Authorization to Bid the 2024 Sanitary Sewer System Manhole Maintenance and Rehabilitation Program (this is a Multi-Municipal Project). (Vote)

The Township Engineer reviewed this and informed the Board that Hanover Township has joined with Upper Macungie, Lower Macungie, Coplay Sewer Authority, for the repair and maintenance of manholes. Hanover Township has 25 manholes with an estimated cost between \$50,000 and \$75,000. This bid allows one award and separate contracts with the contractor for each municipality. This is in reference to Bid 2024-04. The total cost is estimated at \$373,000. After further discussion, it was noted:
